This Waiver and Release of Liability Agreement ("Agreement") is entered into by the undersigned Renter ("Renter") in favor of Bounce Party Club, LLC, a Michigan limited liability company, and its owners, employees, agents, affiliates, and contractors ("Bounce Party Club").

# 1. ACKNOWLEDGMENT AND ASSUMPTION OF RISK

I understand that the use of inflatable bounce houses and related equipment carries inherent risks of injury or damage. I voluntarily assume all such risks for myself and all participants under my supervision.

I agree to inform all participants of the risks and safety rules and accept responsibility for their compliance during the rental period.

This waiver applies for the entire rental duration, including setup, idle time, and breakdown, regardless of whether the equipment is actively in use.

### 2. WAIVER AND RELEASE OF LIABILITY

I fully and forever release and discharge Bounce Party Club from any and all claims or liabilities arising out of injury or damage during the rental period, whether from negligence or otherwise.

This waiver does not apply to claims arising from gross negligence or willful misconduct by Bounce Party Club.

Gross negligence is defined as conduct so reckless as to demonstrate a substantial lack of concern for whether injury results.

#### 3. INDEMNIFICATION

I agree to indemnify and hold harmless Bounce Party Club from any claims or liabilities arising out of the use of its equipment.

### 4. RENTER'S RESPONSIBILITY

I accept full responsibility for supervising all participants using the equipment and for communicating all safety rules.

#### 5. EQUIPMENT CONDITION

I acknowledge that I have inspected the equipment and found it in good working condition at the start of the rental period. I understand I may take photos or videos of any visible damage or concerns before Bounce Party Club leaves the setup location and agree to share such documentation immediately.

### 6. CANCELLATIONS AND REFUNDS

### 8. DAMAGE RESPONSIBILITY AND FEE

I understand and agree that I am responsible for any intentional, negligent, or reckless damage to Bounce Party Club equipment.

I may be charged a minimum of \$150.00, or more depending on the extent of the damage, subject to Bounce Party Club's reasonable assessment and documentation.

I agree to remit payment within 10 business days upon receiving a written notice and invoice.

## 9. RULES AND SAFETY COMPLIANCE

I agree to follow all instructions and safety rules provided by Bounce Party Club. I further acknowledge the following safety guidelines apply during the rental period and must be enforced by me as the responsible renter:

- Adult supervision is required at all times.
- No shoes inside the inflatable.
- No sharp objects, including keys, jewelry, or glasses.
- No food, drinks, or gum inside the inflatable.
- No rough play, wrestling, or climbing on the unit.
- Do not hang on netting, walls, or roofs.
- Limit occupancy by age group and size.
- No silly string, face paint, glitter, or confetti.
- Keep the unit dry unless authorized for water use.
- Exit immediately during rain, lightning, or winds over 15 MPH.
- Do not unplug or move blowers or extension cords.
- Do not exceed posted weight or occupancy limits.

In the event of injury or emergency, I agree to call 911 immediately and notify Bounce Party Club as soon as reasonably possible.

I agree to monitor weather conditions and cease use of the equipment in unsafe weather including, but not limited to, rain, high winds, or lightning.

If I am not the parent or legal guardian of participating minors, I affirm I have obtained written consent from the responsible parties agreeing to the terms of this waiver.
